Conditions for membership in Scen & Film

Membership requirements

1) *Those in artistic occupations* (singers, dancers, actors, performers, directors, set designers, costume designers, choreographers, and others who have:

- a) Completed an education at one of the Swedish national theatre or film academies or another professional education acknowledged by the union board.
- b) Have been employed in accordance with union regulations in an occupation served by Scen & Film for at least six months and during the previous six month period supported oneself financially within these professions
- c) Have been employed in accordance with union regulations in an occupation served by Scen & Film and for at least 12 months supported oneself financially within these professions

The Union board may also approve membership on the basis of special reasons.

2) *Technicians and administrators* who have either:

- a) Completed an education acknowledged by the Union board, or
- b) Are employed in accordance with union regulations within an occupation served by Scen & Film

3) *Company owners* who fill the criteria outlined in 1-2 above.

4) *Students* at professional education institutions within the Scen & Film sphere may become *student members*

A person who is employed or has a company active in any of the occupational areas outlined above but who does not fill the criteria for membership may apply for conditional membership for a period not exceeding three years.

Membership fees

Membership fees for Scen & Film are based on yearly earnings according to the following scale:

- *Student member* fees are 200 SEK per year
- Fees for owners of companies are established on the basis as outlined below.

Company Owners

You who work in part or wholly through your own company can choose either to become a traditional member of Scen & Film, or to be attached to the Scen & Film Servicebolag. As member of the Servicebolag you have the same rights and responsibilities as other Scen & Film members, the advantage being that your membership fee will be tax deductible.

The membership fee for company owners is divided into two parts, the first being a fee to Scen & Film; 160 SEK per month during 2021. The second part is a fee paid to the Servicebolag amounting to 216 SEK per month. The fee to the Servicebolag is tax deductible as is the value added tax 54 SEK (moms) charged. The total cost for this new membership will be less than the traditional membership cost if your company has a declared net income of over 300 000 SEK per year.

TFR (Scen & Film/The Swedish Union for Performing Arts and Film & Rättighetsbolaget /Rights Manager of the Swedish Union for Performing Arts and Film).

Incomes from copyright protected properties (royalties) from broadcasts of television programs, films, video, theatre and other media are increasing in importance for Scen & Film's members.

If you are primarily a performer (actor, singer, dancer, musical or performance artist) or author/originator (director, choreographer, set designer, costume designer, film photographer, animator) your membership also implies you are affiliated to TFR – unless you, within three months after joining Scen & Film, inform Scen & Film otherwise. This means that all copyrights within the areas guarded by Scen & Film as stipulated by current law will be transferred to TFR. If you are connected to SAMI (Swedish Artists' and Musicians' Interest Organization), SAMI has contractual priority of sound recordings pursuant to § 47 Copyright Act.
